2020 Membership Options

SINGLE MEMBERSHIP - \$395 - Includes the stockholder

DOUBLE MEMBERSHIP - \$430 – Includes the stockholder plus spouse or one dependent

FAMILY MEMBERSHIP - \$470 - Includes the stockholder and spouse and all single family members under the age of 25 residing under the same roof or not, providing they are financially supported by the stockholder. Documentation may be required. On their 25th birthday, the child must either join as a new member or pay guest fees as they come or buy a guest pass. Guest fees and guest passes are for a limited number of visits.

EXTENDED FAMILY MEMBERSHIP - \$520 - Includes the stockholder and spouse and parents of the stockholding family living with and being supported by the stockholder.

Associate Membership – Stock purchase not required

A one year membership to the Club at the current applicable dues rate is available. A processing fee of \$75 is added, but would be applied toward purchase of stock if a regular membership was desired for the next year. An associate member (nonstockholder) is unable to hold a position on the Board of Directors or vote on pool affairs which is a privilege reserved for stockholders.

Military and Transient Membership – Stock purchase not required

A member of the military or someone residing in our area on a temporary basis may become a member of the Club without having to buy stock by paying a \$75 processing fee and appropriate dues. This membership category can be used for a maximum of two years. A military or transient member (nonstockholder) is unable to hold a position on the Board of Directors or vote on pool affairs which is a privilege reserved for stockholders.
