

BATTLEFIELD PARK SWIM & RACQUET CLUB

HOUSE RULES

1. GENERAL

The house rules governing the operation of the Battlefield Park Swim and Racquet Club, Inc., and the conduct of members and their guests are published for the information and guidance of all concerned.

2. INFRACTION OF RULES

a. All members and guests are expected to comply with the Corporation's by-laws and these rules and to conduct themselves at all times as ladies and gentlemen and in accordance with the standards of social conduct.

b. The POOL MANAGER and all EMPLOYEES are responsible for assuring that good order is maintained on the Club premises at all times.

c. Any MEMBER of the Club noting improper conduct or an infraction of these rules should report it to the POOL MANAGER, EMPLOYEE, or BOARD PRESIDENT.

d. VIOLATORS of the house rules will be requested to leave the Club premises, and a report of the incident will be made to the Board President. The PRESIDENT will report each such incident to the Board of Directors and will follow the dictates of that body as a punitive action, if any.

3. HOURS OF OPERATION (JUNE—AUGUST) (UNLESS OTHERWISE POSTED)

MID JUNE TO LABOR DAY:

Monday – Friday	11:00 AM – 7:00 PM
Saturday	11:00 AM—8:00 PM
Sunday	12:00 PM—8:00 PM
Holidays	TBA

OPENING DAY TO MID JUNE—Shortened hours will be in effect (as posted).

4. CHILDREN

Parents will be responsible for the conduct of their children at ALL TIMES while on the premises or grounds, and the BOARD OF DIRECTORS may prohibit children from using the facilities of the CLUB for repeated or severe infraction of rules.

5. PICNIC GROUNDS—PAVILION

a. The picnic grounds/pavilion is for the use of members and guest(s) and authorized groups.

b. All members and guest(s) must register at the entrance gate. Members must register and pay for their guest(s).

c. The use of picnic tables, grills, etc., shall be on a first-come, first-serve basis.

6. SWIMMING PRIVILEGES

- a. Members must register and pay for their guest(s) at the entrance gate.
- b. Parents will be responsible for the safety of their own children while they are swimming in the pools.
- c. Children under 10 years of age will not be left at the pool without adult supervision (14 years or older).
- d. Children must be potty trained or wear swim diapers to enter any of the pools.
- e. Horseplay or running on the concrete around pool will not be allowed.
- f. On crowded days, no rafts will be permitted inside the pool (at the discretion of the lifeguards).
- g. There will be no food or soft drinks consumed in close proximity of the pool at any time.
- h. Glass bottles or glass containers will not be permitted inside the pool areas.
- i. No chewing gum allowed in the club facilities.
- j. No hard balls (tennis balls included) allowed in the pool.
- k. No hanging on ropes, ladders, or railings.
- l. No jumping on rafts off the side of the pool.
- m. No water guns allowed.
- n. No bouncing balls on concrete around pool or in bathhouse.
- o. No skateboards.
- p. No wall balling in large pavilion or on swim club buildings (wall balling only in designated areas).
- q. No chicken fighting will be permitted in the pool.

IN DIVING BAY

- a. ONE bounce on diving board.
- b. Go straight off the board (not off the side of the board).
- c. No running on board.
- d. ONE person on board at a time.
- e. No goggles.
- f. No floatation devices.
- g. Swimming in bay at LIFEGUARDS discretion.

DURING STORMS

The POOL is cleared when:

- a. Lightning is sighted.
- b. Bottom of pool is obscured due to rain.
- c. Thunder is HEARD.

The POOL stays CLEARED 30 MINUTES after each lightning flash or until thunder/rain subsides. During lightning children MUST stay under covered areas and not on metal playground equipment. Tennis courts must be cleared during storms.

7. TENNIS

- a. No one is allowed on the tennis courts without tennis shoes.
- b. Courts shall be on a first-come, first-serve basis.
- c. Tennis courts must be cleared during storms.

8. GUEST AND GUEST FEES

- a. Guest(s) must be accompanied by a member.
- b. Guest(s) may visit the pool up to a total of 5 times per seasons. Exceptions maybe granted by the board.
- c. Guest(s) 16 years and older must show a photo ID at the front desk before admitted to the swim club.
- d. Guest fees are as follows:

DAILY:	\$5 Adult
	\$3 Children 5—18 years of age
	\$2 Children 4 years and under

- e. Members who are grandparents may bring their nonmember grandchildren for a season fee of \$50 for the first grandchild and \$25 for each additional grandchild. The grandparent must accompany the grandchild(ren).
- f. Members may have a babysitter accompany the family's children for a fee of \$25/MONTH. The babysitter will be allowed access only when he/she accompanies the family's children.

9. PARTIES

- a. Members may reserve and host a party using all facilities and include in-town guests. The member(s) must pay guest fees. The party cannot reserve the entire pavilion unless they pay a **pavilion reservation fee**.

b. A party reservation must be made with the MANAGER or BOARD PRESIDENT in advance. Parties will be posted on the desk calendar.

d. Parties planned to last after closing will be charged all applicable SECURITY, LIFEGUARD, and miscellaneous expenses.

10. MISCELLANEOUS

a. Animals are not permitted on the premises at any time.

b. The CORPORATION will not be responsible for any accident which might befall any person while using the facilities of the club.

c. The CORPORATION will not be responsible for privately owned articles reported damaged or missing from the premises, nor for any damage to automobiles in the parking zone.

d. Alcoholic beverages will not be permitted on the premises unless authorized by the BOARD.

e. Vaping and smoking is allowed only in the designated area..

f. Members who break house rules, abuse membership privileges, illegally enter the property of the Corporation, etc. may have their membership revoked at the discretion of the BOARD OF DIRECTORS.

g. The BOARD OF DIRECTORS reserves the right to change any rules and/or regulations at their discretion. All changes will be posted.

h. Radios brought into the pool area will be turned on low volume so as not to disturb others using the facility.

11. MEMBERSHIP

a. The Board of Directors reserves the right to withhold or revoke a membership for any reason with a vote of at least two-thirds consensus. Once a membership has been revoked, the member may not be reinstated or return to the property. Stock fees will be returned to the individual at the termination of the membership. Notice of termination and stock refund will be sent to the individual via certified letter. Notice of revoked membership will become record in the membership ledger.

b. A FAMILY MEMBERSHIP includes stockholder and spouse and all single family members under the age of 25 residing under the same roof or not, providing they are financially supported by the stockholder. Documentation may be required. On their 25th birthday, the son/daughter must either join as a new member or pay guest fees as they come or buy a guest pass. (See below, h. AGE OF MATURITY.)

c. SINGLE MEMBERSHIP is the stockholder.

d. DOUBLE MEMBERSHIP is the stockholder plus spouse or one (1) dependent.

e. EXTENDED FAMILY MEMBERSHIP includes stockholder and spouse and parents of the stockholding family living with and being supported by the stockholder.

- f. **DIVORCE** In the event of a divorce, the divorced party not owning stock can purchase new stock for the following year, pay appropriate dues, and the initiation fee will be waived (only if this is a continuous membership).
- g. Dues may be paid in installments during the winter months, but must be paid in full by date posted at the front gate. You will not be allowed pool privileges until paid in full.
- h. **AGE OF MATURITY** Dependents of members who have reached the age of 25 are allowed to join the Club without having to pay an initiation fee if he/she joins within the next year after reaching the age of 25. He/she would be required to purchase stock.
- i. **NONSTOCK MEMBERSHIP** A one (1) year, one time membership to the Club at the current applicable dues rate is available. A premium of \$75 is added, but would be applied toward purchase of stock if a regular membership was desired for the next year.
- j. **MILITARY AND TRANSIENT** A member of the military or someone residing in our area on a temporary basis may become a member of the Club without having to buy stock by paying a \$75 processing fee and appropriate dues. This membership category can be used for a maximum of two (2) years.
- k. **TRANSFER OF MEMBERSHIP** If a member of another local club wishes to transfer to BPS&RC and if they have paid a processing fee to another club, BPSRC's processing fee will be waived. Stock must be purchased and dues paid.
